a) The **Regular Adult Membership** Initiation Fee for the current year is: \$1,500.00 plus GST = \$1,575.00. The Regular Adult Annual Dues for 2010 are \$1,437.00 plus G.S.T. = \$1,478.75. Discounts are available for early payment and paying by Cash, Cheque or Debit Card.

b) The **Regular Adult Membership (Financed), applicants who opt to finance their Entrance Fee** are available on a first come - first pay basis, as there is a limit of 200 members in this category. Applicants who finance their membership are not entitled to vote or hold office until their Entrance Fee is fully paid. The **Entrance Fee plus GST is paid through a mutually agreed payment plan** with two options available:

- I. **Option 1 (3 Year Plan): \$375.00 plus G.S.T. = \$393.75** is required upon acceptance of the application, with three additional payments due by March 1st in each of the next three years. An interest rate of 5% is applied to the outstanding balance and is calculated in each of the payments due.
- II. **Option 2 (4 Year Plan): \$300 plus G.S.T. = \$315.00** is required upon acceptance of the application, with four additional payments due by March 1st in each of the next four years. An interest rate of 5% is applied to the outstanding balance and is calculated in each of the payments due.

2. Privileges:

- I. **Regular Adult Members** shall have full use of the Golf Course, Food & Beverage Facilities and the Golf Shop, subject to such Rules and Regulations as may be determined by the Board of Directors from time to time.
- II. Regular Adult Members (Financed) *shall not have voting privileges* at any Society Meetings, nor any equity in the Society, nor any say in Society matters.
