

The Board of Directors, Management and staff of the Summerland Golf and Country Club would like to take this opportunity to provide you with some highlights from the July 2020 Board of Directors meeting. We would also like to remind you that we all need to remain vigilant and follow the protocols put in place by the club to curb the spread of Covid-19.

As we continue to operate our business during Covid-19, we would like to remind all members and guests to please follow the guidelines put in place by the club to protect your health and the health and safety of our staff. New rules set out by Dr. Bonnie Henry, British Columbia's Provincial Health Officer, that govern the operation of bars, cafes, restaurants, etc., came into effect on July 31. Among other things, the order states that members and guests who are dining inside or on the deck must not stand at the bar to order food and drinks. Your server will come to your table once you are seated. You must remain seated at your table except to use the washroom. Please do not rearrange tables or chairs to create larger groups or move to other tables and sit with different groups of people while you are in the restaurant. Golfers who are ordering food and drinks before their round or at the turn may order at the bar, but are required to wash their hands or use the sanitizer provided beforehand and must not reach over the bar to grab straws, napkins, etc. Please allow staff to serve you. When on the course, if you are purchasing items from the beverage cart server, please keep a distance of 6 feet from the beverage cart and allow her to bring your purchases to you. Do not reach into the ice wells to grab your own drinks.

Wash your hands or use the sanitizer provided when you enter the club house and follow the arrows on the floor when you enter and exit the building to ensure proper traffic flow. When you are sitting inside the restaurant or on the deck, please remember that a maximum of 6 people are allowed to be seated at each table. Keep one end of your table open to allow sufficient space for serving staff to deliver and remove food and beverage items without reaching over you.

We continue to ask members who are comfortable with others in their group to ride together in power carts. We understand that some people may have compromised immune systems,

or they may work in a setting, such as health care, where they could put others at risk if they become infected.

Our golf course has a limited number of power carts available, which means that people who play later in the day may not be able to use a power cart if they are all given out to people who play earlier in the day. If you feel comfortable socializing with members of your playing group after the round by sitting in close contact, sharing a jug of beer, or a snack, please consider riding with them during your game to ensure that everyone who requests or requires a cart is able to use one.

As always, please keep power carts on cart paths wherever they are available and avoid driving near tee boxes, greens, and bunkers. Fill your divots and fix your ball marks on the greens so that our course is in the best shape possible for the enjoyment of everyone who plays it.

We appreciate your cooperation in protecting the health and safety of our members, guests and staff, and in maintaining the exceptional condition of our golf course.
