



2025 MEMBERSHIP APPLICATION FORM

There is currently an Initiation Fee for All Memberships at the Summerland Golf & Country Club with only Junior, Intermediate I, & Non-Resident memberships exempt.

- 1) **Adult Full Play Membership** Unlimited Play, subject to availability.
Regular Adult Annual Dues are \$2349 plus G.S.T. = \$2,466.45
Dues are also payable through an installment plan (see 2025 Dues Schedule).
- 2) **Nine Hole Adult Membership** Unlimited Play for 9 holes per day, subject to availability.
Nine Hole Membership Dues are \$1,699 plus G.S.T. = \$1,783.95
- 3) **Start New At Golf Adult Membership** Unlimited Play after 2pm in March, April, May, September & October; After 3pm in June through August.
S.N.A.G. Membership Dues are \$1199 plus G.S.T. = \$1258.95

- 4) **Limited Play:** Unlimited Play after 1:30pm seven days a week, from season opening to season close, subject to availability. Open to new and existing members.
Limited Play Dues = \$1850 plus G.S.T. = \$1,942.50
- 5) **Full Play Intermediate I & II:** Unlimited Play, subject to availability.
Full Play Intermediate I age restriction is 19 years to 26 years \$999 plus gst = \$1048.95
Full Play Intermediate II age restriction is 27 years to 34 years \$1350 plus gst = \$1417.50
- 6) **Non-Resident Member:** Must live minimum of 100 km. out of Summerland.
Provides 10 complimentary green fees, as well as all other privileges of membership.
Non-Resident Dues = \$666.67 plus G.S.T. = \$700.00

MEMBERSHIP POLICIES & PROCEDURES

New Members of the Club are subject to an Initiation Fee of \$1000 plus gst. This non-transferable, non-refundable fee will be designated to the club's Capital Replacement Fund. This fee can be paid in full at a 5% reduction or with payment plans made available based on the membership category chosen. Junior, Full Play Intermediate I, & Non-Resident categories will be exempt from the Initiation Fee

All members and prospective members are required to review the Membership Policies and Procedures document.

ABOUT THE START NEW AT GOLF (S.N.A.G.) MEMBERSHIP & LIMITED PLAY MEMBERSHIP

In 2014, the Board of Directors introduced a new class of membership referred to as Start New at Golf (or SNAG). This membership is considered to be an introductory membership for new golfers or golfers who had not been a member of our Club before.

- 1) If you previously were a member of Summerland Golf & Country Club, you no longer qualify for the SNAG Membership.
- 2) A new Limited Play Membership Class was introduced in 2015. It is open to anyone, new members as well as existing members. See the Policy and Procedures Manual for a full outline of privileges, however Limited Play Members are restricted to playing golf starting at 1:30 p.m. each day. You are welcome to play earlier, however an upgrade fee of \$15 tax included shall apply for play after 12pm daily, and an upgrade fee of \$25 tax included shall apply prior to 12pm daily.
- 3) Start New At Golf Play Time Restrictions. See the Policies & Procedures document for a full outline of the privileges for this class of membership. Playing time restrictions include the following:
 - a. During the months of March – May 31st, September – End of Season; limited to playing at 2pm or later.
 - b. During the months of June through August, playing at 3pm or later.

You are welcome to play earlier, however an upgrade fee of \$15 tax included shall apply for play after 12pm daily, and an upgrade fee of \$25 tax included shall apply prior to 12pm daily.
